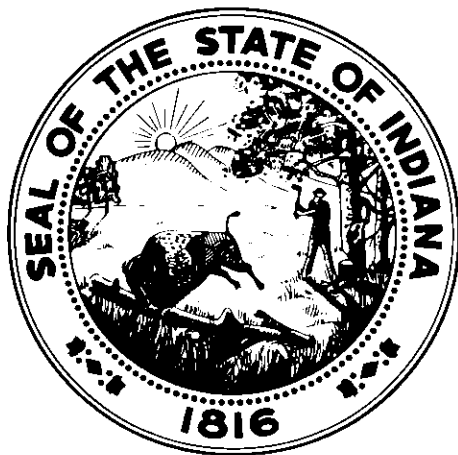

ADDITIONAL ARTICLES

Article VII : AMENDS ARTICLE III, PURPOSES AND RESTATES IN ITS ENTIRETY AS FOLLOWS:

THE PURPOSES OF THE COMPANY SHALL BE TO:

(A) ENABLE THE DEVELOPMENT AND PUBLIC RELEASE OF SOFTWARE TOOLS FOR CREATING
CUSTOMIZED MEDICAL RECORDS SYSTEMS THAT WILL IMPROVE CLINICAL CARE, AND
FACILITATE MEDICAL RESEARCH AND EDUCATION; AND

(B) IN FURTHERANCE OF SUCH PURPOSES, CONDUCT ANY AND ALL LAWFUL BUSINESS AND
ACTIVITIES FOR WHICH LIMITED LIABILITY COMPANIES MAY BE ORGANIZED UNDER THE ACT.

THE COMPANY'S SOLE MEMBER (THE "CORPORATION"), IS AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, AND NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE COMPANY SHALL AT ALL TIMES OPERATE IN A MANNER CONSISTENT WITH THE CHARITABLE PURPOSES OF THE CORPORATION. THE COMPANY IS COMMITTED TO PROVIDING CHARITABLE SERVICES FOR THE BENEFIT OF THE COMMUNITY SERVED BY THE CORPORATION AS A WHOLE, AND TO GIVING CHARITABLE PURPOSES PRIORITY OVER MAXIMIZING PROFITS FOR THE MEMBER OF THE COMPANY.
